**REMINDERS**

- Submission deadlines are the first and third Thursday of the month.
- Hearings are the second and fourth Thursday of the month.
- **It is expected that projects involving additions, new construction or demolition will require a workshop before proceeding to a regular hearing.** Workshops will be held after the hearings as needed.
- If the HPC votes to continue the application to the next hearing, the applicant has four days to submit revisions if necessary.
- All deadlines will be strictly enforced.
- Applicants are strongly encouraged to meet with staff prior to submitting an application.

 (2) Resubmission deadline is early due to Martin Luther King, Jr. holiday.  
 (3) Submission deadline is early due to Independence Day holiday.  
 (4) Resubmission deadline is early due to Labor Day holiday.  
 (5) There will only be one hearing in November  
 (6) There will only be one hearing in December.
