ORDINANCE NO: G-21-10

AN ORDINANCE concerning

The Fiscal Year 2022 Fee Schedule

FOR the purpose of establishing a master schedule of administrative and regulatory fees for Fiscal Year 2022.

SECTION I. NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FREDERICK:

- (a) **Authority.** Under the Annotated Code of Maryland, Local Government Article, § 5-205, the Board of Aldermen may establish and collect reasonable fees and charges for franchises, licenses, or permits as well as reasonable fees and charges associated with the exercise of a governmental or proprietary function exercised by the City.
- (b) **Adoption of fee schedule.** The Fiscal Year 2022 Fee Schedule, attached as Exhibit A hereto and incorporated herein by this reference, is hereby adopted and shall be in effect for Fiscal Year 2022 (July 1, 2021 through June 30, 2022). It shall remain in effect even after the conclusion of Fiscal Year 2022 unless or until it is repealed or otherwise amended.
- (c) **Temporary COVID surcharge for towing.** The surcharge for COVID-related expenses listed under the Police Department's schedule of fees shall expire on the date the Governor of Maryland rescinds the current state of emergency relating to COVID-19.
- (d) **Frederick County.** Notwithstanding the fees established herein, the City will not charge Frederick County, Maryland for permit fees or water and sewer connection fees, in accordance with the Fee Collection Agreement between Frederick County and the City entered into on or about October 2, 1986.

SECTION II. AND BE IT FURTHER ENACTED AND ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FREDERICK, That nothing herein shall be construed to prohibit the City from providing its officials, employees, or retirees with benefits such as a waiver or reduction of fees associated with the use of City facilities or programs.

SECTION III. AND BE IT FURTHER ENACTED AND ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FREDERICK, That nothing herein shall be construed to limit the authority of the Board of Aldermen to adopt additional fees and charges, and that in the event of a conflict between this ordinance and any other ordinance or resolution hereafter adopted, the other ordinance or resolution shall prevail unless otherwise expressly stated therein.


SECTION IV. AND BE IT FURTHER ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FREDERICK, That this ordinance shall take effect on July 1, 2021, and that as of such date Ordinance No. G-20-09 and Ordinance No. G-21-01 will be repealed and of no further force or effect.


SECTION V. AND BE IT FURTHER ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FREDERICK, That the event of a conflict between this ordinance and any other ordinance or resolution previously adopted by the City, this ordinance shall prevail.

SECTION VI. AND BE IT FURTHER ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF FREDERICK THAT in the event any provision, section, sentence, clause, or part of this ordinance shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause, or part of this ordinance, it being the intent of the City that such remainder shall be and shall remain in full force and effect.


