Important Information

- 1) **Initial Submittal:** Complete applications, including all fees, must be filed by no later than 3 pm on the date in the Initial Submittal column (1) above in accordance with the procedures established on the Planning Department's webpage.
- 2) **Development Review Conference (DRC) Meeting:** Meeting with staff to discuss the outstanding issues associated with the plan. The DRC schedule will be published on the Planning Commission's webpage and Applicants will be notified one week in advance of the date in the DRC Meeting column (2).
- 3) **First Resubmittal Deadline:** Deadline date for submitting revised plans addressing staff DRC comments.
- 4) **Second DRC Meeting:** To review the first resubmission addressing the first round of staff DRC Comments:
- 5) **Planning Commission Workshop:** Pending the completion and resolution of all DRC comments, the application will be scheduled for a workshop with the Planning Commission. Workshops are held at City Hall located at 101 N Court Street beginning at 2:00pm unless otherwise noted on the monthly agenda.
- 6) **Second Resubmittal Deadline:** Deadline date for submitting revised plans after PC Workshop meeting for presentation at the PC hearing.
- 7) **Pre-Planning Commission Meeting:** The Friday before the public hearing, a Pre-Planning Commission meeting will be held virtually beginning at 3:00pm unless otherwise noted on the monthly agenda.
- 8) **PC Hearing:** All Planning Commission hearings are held at City Hall located at 101 N Court Street, beginning at 6:00pm unless otherwise noted on the monthly agenda. Please note that some application types require two public hearings. If two public hearings are required, the second will be scheduled for the subsequent month unless otherwise noted.

PUBLIC NOTICE: All applications are subject to the public notice requirements provided in Section 301, Tables 301-1 of the Land Management Code.
