**RENTAL RATES FOR PARK PAVILIONS & BANDSHELL**

**Yard Sale permits** - \$25.00 City residents; \$50 Non-City residents (*in addition to pavilion rental rate*).

**Pavilions:** Pavilion rentals do NOT include field areas.

**Small pavilions and/or pavilions with no restrooms:** Amber Meadows, Baughman's Babee, Catoclin Avenue, E. 3<sup>rd</sup> Street, Gazebo, Grove, Hillcrest, Lucas Village and Stonegate

**City residents - \$20.00                      Non-City residents - \$40.00**

**Medium pavilions:** Emerald Farm, Greenleaf, Lake Coventry, South End, Walnut Ridge, Whittier Lake and Willowbrook

**City residents - \$30.00                      Non-City residents - \$60.00**

**Large pavilions:** Amber Meadows, Carrollton, College Estates, Harmon, Hill Street, Mullinix, Maryvale, Overlook, Riverwalk, and Rosedale

**City residents - \$50.00                      Non-City residents - \$100.00**

**Monocacy Village & Staley Park Pavilions:**

**City residents - \$75.00                      Non-City residents - \$100.00**

**Bandshell – City residents - \$125.00; Non-City residents - \$250.00** This fee will be charged whether or not there is music. Note: there are many stipulations to using the Bandshell, please refer to policy & regulations in the application package.

**Bandshell Restrooms ONLY (when available) – City \$15.00; Non-City \$30.00**

**Bell Tower/Carillon Area – City residents - \$20; Non-City residents - \$40**

	<i>(1/4 Section defined as: NW, SW, NE of Suspension Bridge)</i>	
<b>Entire Creek Area:</b>	City	= \$1,000.00 / day
	NonCity	= \$2,000.00 / day
	<i>(Both sides – S Court Street to Patrick Street)*Due to Shared Use Path, one side of creek must remain open to pedestrian access at all times.</i>

**Dog Park License – City \$15.00 NonCity \$30.00**

**Parking Lots (per day / when available) – Small (25 – 50 spaces) = City - \$50; non-City - \$100**  
Medium (51 – 100 spaces) = City - \$100; non-City - \$200  
Large (101+) = City - \$200; non-City - \$400

**BALL FIELDS, TENNIS, BASKETBALL, & HOCKEY COURTS (Continued)**

**Field User Fees** (*for all hours incurred*) – **\$3.50** per hour City residents (minimum of 51% City residents);  
**\$7.00** per hour non-City residents  
Colleges / Schools - \$25 per hour City Resident; \$50 per hour non-City residents

**Lights for sports fields** - \$25 per hour City residents; \$50 per hour non-City residents

**Tennis Courts** - City - \$10 per time slot per court; non-City \$20 per time slot per court  
(Time Slots = 6am-12 noon, 12 noon-4pm, 4pm – 10pm)

**Basketball Courts** – City - \$10 per day; non-City - \$20 per day

**Inline Hockey Courts** – Riverwalk and/or Hill Street courts only – Per day rates: City - \$25; non-City \$50  
(NOTE: Hill Street Courts are lighted; see additional Light Fees above)
